## Attendee Registration Policies and Terms

### REGISTRATION CANCELLATION/REFUND POLICY

Registration cancellation requests must be received no later than **September 30, 2020** to receive a refund. Submit your cancellation in writing to the NESO Office via email to [registration@neso.org](mailto:registration@neso.org). Telephone cancellations will not be accepted. Your cancellation/refund request should include your name, registration confirmation number, AAO member number and the reason for cancellation. A \$10 cancellation fee will be charged for each person's Annual Meeting registration upon written request until the deadline. No registration refunds will be issued after the cancellation deadline. All approved refunds will be processed within 30 business days of the conclusion of NESOCON 2020.

### CONSENT
